### REQUIREMENTS AND SPECIFICATIONS;

- 1) All installation work must meet manufactures specifications and recommended installation guidelines.
- 2) Vendor to provide to owner all; Packaged instructions and operations manuals, date of installation, and any warrantee information.
- 3) Vendor to provide when requested S.D.S sheets to owners representative.
- 4) Any and all lead base material shall be treated in accordance with all State and local abatement regulations.
  - a. To the owners knowledge there are no lead based materials in the requested work area and description.
- 5) All bids over \$2,000.00 to include provisions for the Davis-Bacon Act (DBA)
- 6) All Vendor/Contractors must have active California state Contractors license and maintain certifications and insurance required for the duration of the contract/agreement required by the state of California.
- 7) All work to be performed in a professional and timely manner.
- 8) All work to be performed by signed contract terms and conditions provided by owners (Foundation for ECE) agent or representative.
- 9) Bids shall not include a request for deposit

## Scope of Work

**Location(s):** LA MIRADA HEAD START

**Address:** 5637 La Mirada Ave. Los Angeles, Ca 90038

**Submission Deadline:** December 9, 2020

**Project Completion Date:** MARCH 31, 2021

### **DESCRIPTION:**

Itemize separate costs for projects #1 and #2. As described for the kitchen upgrades, play equipment, PIP surfacing, concrete repairs, and shade if needing replacement.

#### Interior:

Remove and replace kitchen cabinets and countertops (color TBD), cabinets to accommodate dishwasher and food warmer.

#### Exterior-Playground:

Remove existing playground equipment and PIP, install new age appropriate play structure ages 2-5 with new rubber Pour in Play surfacing. Assess the shade fabric, post pads and concrete for repair or replacement need. All material must meet manufacture specifications and recommendations for installation. A Playground Inspection Audit by a Certified Playground inspector must be included to ensure proper installation meets health and safety compliance. Prevailing wages must be included if project exceeds \$2000 per Davis Bacon Act.

Contractor will be responsible for any permits or engineering required for installation, cleaning and removal of all trash and debris from the site.

Pictures of completed project, Davis Bacon posting picture, Certified Payroll and Interview will be due with invoicing.
