DESCRIPTION:

Design, purchase and install inclusive playground equipment that promotes, and allows use by children with all abilities, and those with disabilities. Projected budget NTE \$42,000.

Note: Playground structure and PIP was recently replaced. This project is intended to add enhancements to outdoor play space for children 3-5 years of age, to include those with varying abilities

Important Information: Prevailing wages must be included for projects exceeding \$2000 per Davis Bacon Act. Contractor will be responsible for any permits or engineering required for installation, cleaning and removal of all debris.

Agency Information: Foundation for ECE, Inc. is a nonprofit agency that operates multiple Head Start- Early Head Start & State Preschool in Los Angeles County CA. We are funded by the Federal Office of Head Start (indirectly via LACOE) and CA Department of Education.

REQUIREMENTS AND SPECIFICATIONS;

- 1) All bids over \$2,000.00 to include provisions for the Davis-Bacon Act (DBA)
- 2) All Vendor/Contractors must have active California state Contractors license and maintain certifications and insurance required for the duration of the contract/agreement required by the state of California for the job they are performing
- 3) All installation work must meet manufactures specifications and recommended installation guidelines.
- 4) Vendor to provide to owner all; Packaged instructions and operations manuals, date of installation, and any warranty information.
- 5) Vendor to provide when requested S.D.S sheets to owners representative.
- 6) Any and all lead base material shall be treated in accordance with all State and local abatement regulations.
 - a. To the owners knowledge there are no lead based materials in the requested work area and description.
- 7) All work to be performed in a professional and timely manner.
- 8) All work to be performed by signed contract terms and conditions provided by owners (Foundation for ECE) agent or representative.
